Subject: Results of Actions Taken in the August 2006 Electronic Meeting of the Board of Directors

Dear Members,

The following motions were considered in the August 2006 Electronic Meeting of the NAWCC Board of Directors.

The following motion was considered following approval of a rules suspension motion to consider the motion on a 'fast track'. A quorum being present, the rules suspension motion was approved by a two-thirds (2/3) vote of the Board.

MOTION: Made by Director Hubby, seconded by Director McIntyre: Resolved, that the Greater Los Angeles Regional (GLAR) be authorized to conduct an experiment to evaluate the concept of second day public entry at their Regional Convention scheduled for February 2 and 3, 2007 at the Pasadena Civic Center, Pasadena, CA. Further, that this experiment be based on a proposal submitted to the Board and attached herewith, in which the normal rules for admittance under Article XV Section 6(c) of the Standing Rules will apply on the first day (Feb. 2) but be suspended to permit entry of non-members for the activities scheduled for the second day (Feb. 3); said proposal requiring a report of attendance, financial information, and other operational matters for both private and public days to be submitted to the Board within 60 days following the event.

A quorum being present, the motion is approved having received greater than a two-thirds (2/3) majority vote of the Board.
