The **EXECUTIVE DIRECTOR**, Steve Humphrey, made the following comments:

- •The 2015 election is underway. Currently 8% of the eligible membership have voted electronically. Paper ballots have been mailed to members who have not yet voted. 2455 eligible members, or 15%, voted in the 2013 election.
- •A discussion of the Marketing General campaign and its projected membership acquisitions was held. Total numbers have yet to be determined.
- •A budget update has been posted on the message board. The current forecast predicts a deficit of \$33,000 by the end of FY 2015, mostly due to the cost of the MGI campaign, the current election and necessary building repairs.
- •The Director's Quarterly Report will be available this afternoon.

Endowment Campaign Director, George Goolsby, reported that no new or significant additions were made to the campaign this past month.
