


- For the month of June, we had a deficit from operations of (\$30,812) which included the purchase of (\$10,000) in PPE Supplies and (\$7,718) for consultant fees for server migration of the Microsoft exchange and IMIS software. We had non-operational deficit of (\$14,873) which included net unrealized gains of \$39,496 and depreciation expense of (\$23,557) in June. Year-to-date we have a deficit from operations of (\$14,839) and a non-operational surplus due to net unrealized gains on investments of \$343,080 and depreciation of (\$70,671).
- Member Services Surplus was less than prior year by (\$11,350) due to membership continuing to decline.
 A portion of this decline is due to the COVID-19 cancelling of various Regionals and the National Convention. Our membership total for June is 10,759; down from the prior year.
- Development showed a surplus of \$2,951 due to members donating for the annual appeal and a year-todate surplus of \$32,741 (which includes monies for the roof replacement project). So far we have raised \$168,921 for the roof (includes \$100K bequest). A huge thank you to the membership for supporting us!
- The Net Liquidity for the month is \$688,359 for the month due to the monies received from the annual appeal.
- Total donations for the month totaled \$78,022. Endowment donations of \$100 were received during the month. Also two chapters donated \$1,000 during the month. We received \$1,320 in donations for the roof replacement, \$1,500 in additional restricted donations, \$185 in donations from the message board users, \$65,000 in transition funds and the remaining were general donations of \$8,917.
- Investments (without charitable annuities of \$239,046) totaled \$2,907,000 (at market value) and have recovered from the March Covid losses. Our investment dividends totaled \$9,734 for the month.

We continue to have the museum and library closed to the public due to the roof replacement which began July 13th. The project is halfway complete. The roof replacement is estimated to cost \$320,000 and we continue to accept donations to help cover the cost of this project. This work will continue until early September. Thank you to the generous donors who are helping to contribute to this cause.

Audit work wrapped up at the end of July and a rough draft will be sent to the Finance Committee within the next few days.

We have received a lot of phone calls inquiring when the museum will be opening. Everyone seems excited and anxious to come visit us.




