To ensure that this event is fun, welcoming, successful, and safe for all attendees, volunteers, and staff, event management requires that all attendees, including sponsors and exhibitors, agree to abide by all rules. Failure to do so may result in removal from the event and suspension of membership privileges.

Event Rules: • Please comply with all event rules and instructions from event management whether written or verbal.

- Please treat staff and all attendees with respect. Aggressive behavior is not welcome and will not be tolerated.
- Firearms are not permitted in NAWCC areas, including the mart, lecture rooms, and banquet functions.
- Smoking is permitted in designated areas only.
- Personal riding conveyances are not permitted in the mart room unless prescribed by a physician.
- No pets. Only registered service animals are permitted in NAWCC event areas including the mart.
- Outside food and beverages are not permitted in the convention building.

Additional Table Holder, Dealer, and Exhibitor Rules:

- Keep aisles and exits clear of obstructions.
- Check your table(s) and verify that table legs are in the fully locked position and folding chairs are fully open and functional.
- Observe all provisions in the NAWCC Member Code of Ethical Conduct, including:
 - Providing buyers with all known information regarding any item offered for sale, and clearly identifying all known or suspected alterations, defects, substitutions, or reproduction.
 - Counterfeit items are not permitted on the premises. The sale of counterfeit items is a criminal offense.
 - The sale or trade of any horological items using deceptive practices is prohibited including: a) false or misleading claims of scarcity, age, value, condition, provenance, or investment potential and b) false or misleading representation of reproductions or replicas unless clearly identified as reproductions or replicas.
- Non-Horological items are permitted for sale provided appropriate and of interest to Horological collectors. No weaponry is permitted. Event management may require the removal of inappropriate or non-Horological items at their sole discretion.

Liability Disclaimer & Indemnification Statement

This Disclaimer & Indemnification Agreement is governed by and shall be construed under the laws of the Commonwealth of Pennsylvania, without regard to its conflicts of laws rules. Any dispute, claim, or cause of action arising out of or in connection with this Agreement shall be brought in a court sitting in the Commonwealth of Pennsylvania without exception. Each party hereto irrevocably submits him/itself to the jurisdiction of either the United States District Court for the Eastern District of Pennsylvania, or to the Commonwealth of Pennsylvania, courts in Lancaster County Pennsylvania, for the purposes of any such suit, action, or proceeding. In the event of a breach of the provisions of this Agreement, the non-breaching party shall be entitled to recover its costs and reasonable attorney's fees.

By attending this NAWCC event, you and any guests voluntarily assume all risks including exposure to COVID-19 and other infectious diseases, and further agree to indemnify, defend, and hold harmless NAWCC Inc., and its officers, directors, agents, contractors, employees, members, and volunteers from and against any and all illness, injury, demands, claims, damages to persons or property, losses and liabilities, including reasonable attorneys' fees arising out of or caused by attending any and all activities associated with this event.

Statement Regarding Sales Tax
